Department Reports

Chief Hoevelmann reported the following:

- Representatives for our MOFAD insurance have been meeting with the crews to explain how MOFAD works.
- The crews are training on hazmat.
- An update was given on apparatus maintenance.
- The Run Summary Report for the week January 20th through January 26th was read. A total of 128 Fire and EMS and 177 Ambulance calls were ran. There were several working fires included in those numbers.

Directors Report

The Treasurer's Report for January 29, 2019 was presented. The General Fund had expenses which totaled \$28,570.83; the Ambulance Fund expenses of \$6,280.44; the Capital Improvements Fund expenses of \$10,525.85; the Payroll Fund expenses of \$6,666.66, the Pension Fund expenses of \$81,491.87; and the Vision Fund expenses of \$803.70. Director Mahaffy made a motion, which was seconded by Director Carmack that effective February 1, 2019 the fire district will bill \$175 for treat no transport calls and \$125 for fall assist calls.
