# Department Reports

Battalion Chief Dauster presented an update on Training.

Chief Hoevelmann presented the Apparatus Maintenance report.

Chief Hoevelmann read the Run Report for the week of March 27th through April 2nd, 2022. There were 88 Fire and EMS calls and 194 Ambulance calls.

# Directors Report

The Treasurer's Report for April 5th, 2022 was presented. The General fund expenses of \$11,149.63; the Ambulance fund expenses of \$2,145.79; the Capital Improvement fund expenses of \$1,274.73; Payroll fund expenses of \$314,833.42; the Vision fund expenses of \$426.70 and the Retiree Medical expenses of \$2,391.49. There were no expenses for Pension, Dispatch or Debt Service. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

### Unfinished Business

### New Business.

Fire Marshal Robinson presented the Board of Directors with Resolution No 2022-04 allowing the relocation of fire hydrant 85 feet to Buttonwood Court; Resolution No 2022-05 allowing the relocation of fire hydrant 75 feet to 2463 Soundview Court and Resolution No 2022-06 allowing the relocation of fire hydrant 70 feet to 2657 Clovermere Court. Director Mahaffy made a motion, which was seconded by Director Carmack to approve Resolutions 2022-04, 2022-05 and 2022-06 in which Missouri American Water shall, in accordance with the recommendation of the Missouri Inspection Bureau and with the approval of the Fire Marshal of the Florissant Valley Fire Protection District, relocate said fire hydrants. All Directors voted in favor of this motion.

There was a discussion regarding current radios with concerns of repairs, decreasing software support and costs for replacement as the radios reach half of their lifespan.
