Chief Seppelt reported the following:

- An update was given on the apparatus maintenance.
- The Run Summary Report for the week April 8th through April 14th was read. A total of 108 Fire and EMS and 147 Ambulance calls were ran. We had several working fires included in those numbers.

Directors Report

The Treasurer's Report for April 17, 2018 was presented. The General Fund had expenses which totaled \$4,097.57; the Ambulance Fund expenses of \$3,587.40; the Payroll Fund expenses of \$230,706.10; and the Vision Fund expenses of \$492.29. There were no expenses for the Capital Improvements, Debt, Dispatch, or Pension Funds. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

Director Lubiewski thanked everyone for all their hard work. Director Carmack thanked Chief Seppelt and Battalion Chief Carroll for their part in the funeral procession for Rick Puckett. Director Mahaffy thanked everyone for allowing him to attend the final inspection of the new ambulance at Demers. Director Mahaffy also thanked Brian Grossenheider and Rob Lore for the great job they did on EMS call. Because of their actions the patient survived.
