### Minutes

Director Mahaffy made a motion to approve the Regular minutes from April 8, 2025 which was seconded by Director Carmack. All Directors voted in favor of this motion.

There was a motion made by Director Carmack, which was seconded by Director Mahaffy, to approve the bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.
