Regular Meeting of the Board of Directors of May 6, 2025

The meeting was called to order at 7:30 a.m. by Director Lubiewski. Those in attendance were Fire Board Directors Dan Lubiewski, Mike Mahaffy, and Bob Carmack, Fire Chief Jason Hoevelmann, Assistant Fire Chief Brian McHugh, Fire Marshal Cliff Robinson, Chief Medical Officer Mark Flauter, Shop Steward AJ Freihoff, Shift Rep Brett Feldewerth, Attorney Dan Bruntrager, Danny Cunningham, and Office Manager Laura McIntosh.

Director Mahaffy made a motion, which was seconded by Director Carmack to amend the meeting agenda to allow for the swearing in of Director Carmack. All Directors voted in favor of this motion. Attorney Dan Bruntrager facilitated the official swearing in of Director Carmack. Director Carmack stated that he is thankful for the honor to serve the District.

Director Mahaffy made a motion, which was seconded by Director Carmack to go into closed executive session with only Board members and the District Attorney, Dan Bruntrager. All Directors voted in favor of this motion. Adjourned open session at 8:28am for closed executive session.

The meeting was called to reopen at 8:29 a.m. Director Lubiewski left with a quorum present. Director Mahaffy made a motion, which was seconded by Director Carmack to table the personnel issue for today. Both Directors voted in favor of this motion.

Director Carmack made a motion to amend the agenda to allow for the rescheduling of Kevin Fairlie regarding EMS Compliance until all three Directors can be present to hear his presentation and have the opportunity to ask questions. Dan Bruntrager stated that he would like to be present as well and suggested that 5/20/2025 would work for him. It was decided to move the presentation to the meeting of May 20th.

Chief Medical Officer Flauter stated that the timeline for completion of the remounted ambulance will be in July. A discussion took place.

Chief Hoevelmann mentioned that he and other FVFPD members traveled to Cedar Hill Fire Protection District to attend the swearing in and pinning of Sullivan Clancy, son of the late Timothy Clancy, FVFPD member who passed away late last year. A discussion took place.
