Minutes

Director Mahaffy made a motion to approve the Regular minutes from May 6, 2025 which was seconded by Director Carmack. All Directors voted in favor of this motion.

There were no expenses for Pension, Dispatch or Debt Service. There was a motion made by Director Carmack, which was seconded by Director Mahaffy, to approve the bills and transfer the necessary funds for the operation of the Fire District.
