Director Mahaffy made a motion to approve the Regular meeting minutes from May 11, 2021 which was seconded by Director Carmack. All Directors voted in favor of this motion.

Department Reports

Chief Hoevelmann reported the following training:

Battalion Chief Kleffner gave an update on the Apparatus Maintenance and reported that Ambulance 4017 was hit by an un-insured motorist.

Chief Hoevelmann read the Run Summary Report for May 9th thru May 15th. A total of 62 Fire and EMS and 197 Ambulance calls were ran.

Directors Report

Director Lubiewski reported that the bylaws were approved for the MACFPD.

The Treasurer's Report for May 18, 2021 was presented. The General Fund had expenses which totaled \$164,137.62; the Ambulance Fund expenses of \$21,377.46; and the Payroll Fund expenses of \$276,831.27. There were no expenses for Capital Improvements, Debt Service, Dispatch, Pension, Retiree Medical, or Vision Funds There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District.
