Attorney's Report

Attorney Dan Bruntrager reported on House Bill 1854 and some of the items pertaining to our Fire District. The Board of Directors meeting fees have been increased by \$50 per meeting (maximum 1 meeting per week). This will not take place until a Board member is re-elected. He also reported on how a City can asked to be annexed into a Fire District: the City must make a request, the District has to endorse it, then it goes to the Court and the residents must vote on it and it has to pass with a majority of the vote.
