The General Fund had expenses which totaled \$158,907.14; the Ambulance Fund expenses of \$1,644.50; the Capital Improvements Fund expenses of \$3,703.67; the Payroll Fund expenses of \$234,210.99; the Pension Fund expenses of \$87,839.25 and the Vision Fund expenses of \$457.19. There were no expenses for the Debt Service Fund; and Dispatch Fund There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

Directors Lubiewski and Carmack welcomed Emily Rau aboard.

Accountant Rick Rognan presented the Financial Report for April. Mr. Rognan also presented the proposed Amended Budget for 2018 and the proposed future appropriations. All Directors voted in favor of this motion.
