Minutes

Director Mahaffy made a motion to approve the Regular meeting minutes and the Executive meeting minutes from May 9, 2017 which was seconded by Director Carmack. All Directors voted in favor of this motion.

Department Reports

Chief Seppelt reported the following:

- Crews will train with North County Training next week on Hazmat and have Pediatric training the following week.
- An update was given on apparatus maintenance.
- The Run Summary Report for the week May 14, 2017 through May 20, 2017 was read. A
 total of 132 Fire and EMS and 189 Ambulance calls were ran. There were several working
 fires included in these numbers.

Directors Report

The Treasurer's Report for May 23, 2017 was presented. The General Fund had expenses which totaled \$38,334.58; the Payroll Fund expenses of \$210,468.10; the Ambulance Fund expenses of \$10,983.23; the Capital Improvements Fund expenses of \$31,389.98; and the Vision Fund expenses of \$1,612.14. There were no expenses for the Debt Service, Dispatch, or Pension Funds. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

All Directors voted in favor of this motion.
