# Directors Report

The Treasurer's Report for May 27, 2025 was presented. The General fund expenses of \$4,544.07; the Ambulance fund expenses of \$1,280.67; and the Payroll expenses of \$363,116.84. There were no expenses for Vision, Capital Improvement, Pension, Dispatch, Retiree Medical or Debt Service. All Directors voted in favor of this motion.
