Minutes

Department Reports

Chief Hoevelmann reported the following:

- Training Yoga, City Loads, and Preplanning.
- An update was given on the Apparatus Maintenance.
- The Run Summary Report for June 6th thru June 12th was read. A total of 82 Fire and EMS and 174 Ambulance calls were ran.

Directors Report

The Directors reported that the MACFPD Conference was very informative and well ran. They thanked Captain McHugh for all his work in planning and setting up the conference.

The Treasurer's Report for June 15, 2021 was presented. The General Fund had expenses which totaled \$34,445.25; the Ambulance Fund expenses of \$21,565.26; the Capital Improvements Fund expenses of \$515.00; and the Vision Fund expenses of \$592.30. There were no expenses for Debt Service, Dispatch, Payroll, Pension, or Retiree Medical Funds There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District.
