Chief Hoevelmann reported the following:

- Crews are training on Water Supply and DePaul is doing EMS training.
- An update was given on apparatus maintenance.
- The Run Summary Report was read for the week June 23rd through June 29th. A total of 107 Fire and EMS and 180 Ambulance calls were ran. Included in these number were a couple working fires. The Canteen did an excellent job on the apartment fire. We have run 6,149 calls year to date.
