Minutes

Department Reports

Chief Hoevelmann reported the following:

- The Run Summary Report was read for the week June 30th through July 6th. A total of 118 Fire and EMS and 148 Ambulance calls were ran.

Directors Report

The Treasurer's Report for July 9, 2019 was presented.
