Minutes

Director Carmack made a motion, which was seconded by Director Mahaffy, to accept Resolution 07222025 as written. All Directors voted in favor of this motion.

Directors Report

The Treasurer's Report for July 22, 2025 was presented. The General fund expenses of \$160,100.21; the Ambulance fund expenses of \$17,448.14; the Capital Improvement fund expenses of \$134,098.28; the Payroll expenses of \$2,870.67; the Retiree Medical Trust expenses of \$496.80; and the Vision fund expenses of \$518.92. There were no expenses for Pension, Dispatch, or Debt Service. There was a motion made by Director Carmack, which was seconded by Director Mahaffy, to approve the bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

Unfinished Business

Chief McHugh requested Board approval for a bidding process for General Contractor for completion of House 1 addition with open timeline July 29, 2025 through August 24, 2025 at 2pm, interviews to follow and final recommendation for the Board on September 9, 2025. Director Mahaffy made a motion, which was seconded by Director Carmack to approve the bidding process and timeline as presented for General Contractor for the addition to House 1. All Directors voted in favor of this motion.

Chief McHugh advised that shift meetings are taking place this week regarding Rescue Squad at House 2 including equipment, training needed to accommodate the special operations. A discussion took place.

New Business

Chief McHugh requested approval with the recent renovations to the firehouses, personalized bedding/blankets with FVFPD logo and name purchased for each member for a total of \$5,800.00. Director Mahaffy made a motion, which was seconded by Director Carmack to approve the purchase of personalized bedding for each member. All Directors voted in favor of this motion.

There was a discussion regarding available grants, current open grants and the possibility of FVFPD applying for additional grants. Chief McHugh stated that the District has not received any funds from the SCBA grant awarded last year from AFG as a result of the freeze from the Federal administration. Chief McHugh also stated that the District utilizes Dave Klee for grant writing services, and he is currently writing grants for physicals, mental health services, and additional employees. A discussion followed.

Chief Medical Officer Flauter provided an update regarding GEMT and state funding with the assistance of Kevin Farilie as rules change very rapidly, the program remains very liquid. A discussion took place.

With no further business to come before the Board, there was a motion made by Director Carmack, which was seconded by Director Mahaffy, to adjourn this meeting. All Directors voted in favor of this motion. The meeting was adjourned at approximately 8:16 a.m.
