Department Reports

Chief Hoevelmann reported the following:

- Crews are participating in North County training, Yoga for First Responders, and Stretching Routines. We will also have a Nutritionist here once a quarter. Chief Medical Officer Flauter recently attended the Pinnacle Conference and Chief Hoevelmann and Captain Dauster attend the Chiefs Conference in Atlanta.

Directors Report

The Treasurer's Report for August 13, 2019 was presented.
