Battalion Chief Russell Kleffner reported the following training:

Battalion Chief Russ Kleffner gave an update on Apparatus Maintenance.

Chief Hoevelmann read the Run Summary Report for August 8th through August 14th. A total of 99 Fire and EMS and 205 Ambulance calls were ran with 8,400 calls year to date.

# Directors Report

All Directors voted in favor of this motion.
