Directors Report

The Treasurer's Report for August 20, 2019 was presented. The General Fund had expenses which totaled \$21,423.27; the Ambulance Fund expenses of \$3,100.01, and the Capital Improvements Fund expenses of \$1,774.42. There were no expenses for the Debt Service, Dispatch, Payroll, Pension, or Vision Funds.
