Minutes

Director Mahaffy made a motion to approve the Regular meeting minutes from August 17, 2021 which was seconded by Director Carmack. All Directors voted in favor of this motion.

Department Reports

Chief Medical Officer Flauter reported the following training:

- Active shooter training with hands on component in September

On behalf of Battalion Chief Russ Kleffner, Chief Hoevelmann gave an update on Apparatus Maintenance.

Chief Hoevelmann read the Run Summary Report for August 15th through August 21st. A total of 80 Fire and EMS and 217 Ambulance calls were ran with 8,600 calls year to date.

Directors Report

The Treasurer's Report for August 24, 2021 was presented. The General fund had expenses which totaled \$181,329.50; the Payroll fund expenses of \$263,685.39; the Ambulance fund expenses of \$3,845.43; the Capital Improvements fund expenses of \$1,587.99; the Vision fund expenses of \$641.71. There were no expenses for Retiree Medical, Debt Service, Dispatch, or Pension. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.
