Minutes

Director Mahaffy made a motion, which was seconded by Director Carmack to approve the Regular meeting minutes from September 24, 2019. All Directors voted in favor of this motion.

Department Reports

Chief Hoevelmann's Report:

- DePaul, and Commercial Water supply training is on-going. The Strike Team will have drills at the end of the month.
- An update was given on the Apparatus maintenance.
- The Run Summary Report for the week September 22nd through September 28th was read.
 A total of 104 Fire and EMS and 168 Ambulance calls were ran.
- The crews did a great job helping with the water recovery in the creek yesterday. The
 Canteen team also did a great job and we really appreciate them volunteering their time for
 us.

Canteen Member Danny Cunningham gave an update on the calls they have responded to. They are averaging 2 to 3 calls per month.

Directors Report

The Treasurer's Report for October 1, 2019 was presented. The General Fund had expenses which totaled \$15,214.79; the Ambulance Fund expenses of \$1,102.75; the Capital Improvements Fund of \$18,237.52; and the Vision Fund expenses of \$517.26. There were no expenses for the Debt Service, Dispatch, Payroll or Pension Funds. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

All Directors voted in favor of this motion.
- There was discussion on equipment needs and bids were presented to the Board.

 - o Director Carmack made a motion, which was seconded by Director Mahaffy, to purchase the forcible entry door in the amount of \$8,300. All Directors voted in favor of this motion.
 - o Director Mahaffy made a motion, which was seconded by Director Carmack, to purchase the cargo trailer for PR equipment in the amount of \$4,200. All Directors voted in favor of this motion.
 - o Director Mahaffy made a motion, which was seconded by Director Carmack, to purchase the SCBA storage racks for all three houses in the amount of ~\$4,300 (total for all). All Directors voted in favor of this motion.

With no further business to come before the Board, there was a motion made by Director Lubiewski, which was seconded by Director Mahaffy to adjourn this meeting. All Directors voted in favor of this motion. The meeting adjourned at approximately 8:05 a.m.
