Director Mahaffy made a motion, which was seconded by Director Carmack to approve the Regular meeting minutes from December 18, 2018. All Directors voted in favor of this motion.

Department Reports

Fire Marshal Robinson reported the following:

- All shifts have completed the Advanced Stroke class.
- An update was given on apparatus maintenance.
- The Run Summary Report for the week December 9th through December 15th was read. A total of 99 Fire and EMS and 164 Ambulance calls were ran and for the short period of December 16th through December 20th a total of 82 Fire and EMS and 1114 Ambulance calls were ran.

Directors Report

The Treasurer's Report for December 27, 2018 was presented. The General Fund had expenses which totaled \$10,372.52; the Ambulance Fund expenses of \$2,329.37; the Capital Improvements Fund expenses of \$159.00; the Payroll Fund expenses of \$225,499.03; the Pension Fund expenses of \$81,491.87; and the Vision Fund expenses of \$2,038.83. There were no expenses for the Debt or Dispatch Funds. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.



The Treasurer's Report for January 2, 2019 was presented. The General Fund had expenses which totaled \$690,397.85; the Debt Service Fund expenses of \$1050.00; and the Pension Fund expenses of \$69,743.84. There were no expenses for the Ambulance, Capital Improvements, Dispatch, Payroll or Vision Funds. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

Director Mahaffy made a motion, which was seconded by Director Carmack to move \$2,000,000 from the General Fund to the Pension Fund as soon as the money is available to move. All Directors voted in favor of this motion.
