# Directors Report

The Directors thanked the Employees and Canteen Members for all their hard work this year.

The Treasurer's Report for December 31, 2019 was presented. The General Fund had expenses which totaled \$50,181.35; the Ambulance Fund expenses of \$7,391.50; the Capital Improvements Fund expenses of \$136,559.33; the Payroll Fund expenses of \$231,664.26; the Pension Fund expenses of \$87,839.25; and the Vision Fund expenses of \$3,769.62. There were no expenses for the Debt Service, or Dispatch Funds. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.

The Treasurer's Report for January 1, 2020 was presented. The General Fund had expenses which totaled \$378,833.99; the Payroll Fund (HSA) expenses of \$404,100.00; the Debt Service expenses of \$1,000.00; and the Retiree Medical expenses of \$13,270.56; There were no expenses for the Ambulance, Capital Improvements, Dispatch, Pension, or Vision Funds. There was a motion made by Director Carmack and seconded by Director Mahaffy to approve these bills and transfer the necessary funds for the operation of the Fire District. All Directors voted in favor of this motion.
