The Fire District or any other governmental agency may, at its discretion, purchase from this RFP any additional quantities through sixty (60) days from the bid opening date.

The bid price must remain valid until sixty (60) days from the bid opening date.

Each bid shall be accompanied by a detailed set of specifications from the manufacturer showing the exact product bid and all accessories. Failure to submit such detailed specifications will be cause for rejection of the bid.

For easy review, bids shall follow specifications item by item. Any exceptions will be noted on a separate sheet, at the end of the bid, listed item by item. In addition, any options to the bid items shall be listed clearly on a separate sheet of paper.
